III. Registration for Participation and Conditions

- 1. The participation in the Event is voluntary
- Any physical or law entity who has interest in presenting of his/her production or services and holding active
 negotiations with the potential foreign and domestic partners shall be the <u>Slovak participant</u> under the
 following condition: the entity shall be established in the Slovak Republic and shall operate mostly, but not
 only in the smart technologies, AI, engineering, electrical engineering, power engineering, ICT and its
 associated areas
- 3. Any physical or law entity who has interest in holding active negotiations with the Slovak production entities operating mostly, but not only in the above-mentioned sectors with the aim to create cooperation relations leading into **buying** the production output or services or in forming a Joint Venture shall be <u>foreign participant</u>
- 4. For successful registration complete the <u>Registration Form</u> at the SARIO web site engaged to the event and settle the registration fee according to the <u>price list</u>. The final invoice will be issued by the Organiser upon the event
- 5. Each Participant shall provide true data which will be afterwards used for the communication and issuing tax documents
- In the period from 11th to 16th November 2025 until 12PM CET (matchmaking program) registered
 participants will choose their partners for B2B negotiations themselves. Organisers are not responsible for
 the selection of partners
- 7. The insertion into the Matchmaking Program will be confirmed upon the payment of the fee according to the article III/4
- 8. Any objections regarding the Participant's payment shall be submitted not later than 14 days upon the receipt of the invoice

IV. Final Provisions

- The Participant consents that the company profile will be published on the web page of the Organiser and Event Partners
- Time schedule and the Event organisation conditions will be posted on the Organizer's website by November 15th 2025, until 12PM CEST
- 3. The Organiser reserves the right to cancel or postpone the Event date due to insufficient number of Participants or other objective reasons. The Organiser shall inform the Participant on the Event cancellation within time period from 11th to 17th of November 2025. If the Event will be cancelled by the Organiser, registration fee will be refunded in full
- The Organizer reserve the right to alter the form of the Event in case of Vis mayor or objective reasons. Participants will be informed regarding the alteration of the format of the Event and new registration fee by November 16th 2025
